Other fees: Issuance, renewal or reinstatement of Alarm Permit: Residential, \$50.00; Commercial, \$110.00. Response to false alarm, if more than five false alarms have occurred within the preceding 12-month period: \$75.00. Sexually Oriented Businesses: Initial registration for exemption, \$50.00; Renewal of exemption, \$25.00; Initial or renewal application for Sexually Oriented Business License, \$500.00; Initial or renewal application for Operator's License: \$50.00; Issuance of duplicate registration or license: \$15.00.
