Motion by Commissioner Moore and seconded by Commissioner Sonleitner to authorize, as to the next level of applying budget numbers, the upgrading of the Commissioners' support for the First Responders as has been outlined in (back-up material) Planning Question #1. Regarding the other planning questions in the back-up material, the Commissioners' Court instructs the Planning and Budget Office, the Department of Emergency Services, and the Justice and Public Safety Department to work on a Travis County funded and operated Ground Transport System for the area outside the city limits of Austin. The issues as to the level of response that will be funded should be left open until the Court sees those numbers (all levels should be looked at). Also, as part of the exercise of putting this into a budget configuration, Travis County should:

- 1) assume that they remain in an agreement for the Medical Director with the City of Austin:
- 2) continue the clinical practice arrangement and the EMS training that is currently in place;
- 3) be establishing and looking at the configuration of a stakeholder oversight board for advice (not only on the system when it is in place, but on the formulation of that system and the current budget), or some committee that involves medical oversight and those standards;
- 4) involve the County Attorney's Office so they would formulate, for the Court, potential agreements that the cities could look at so the Court can get an indication from each city outside of Austin as to which ones would be interested in entering into an agreement with Travis County to use this system;
- 5) ask that the County Attorney's Office also work on the agreements that would be needed to enter into with the Emergency Services Districts for the sharing of resources; and
- 6) also ask that the County Attorney's Office work on the agreement that Travis County would need, with the City of Austin, to continue the arrangements, and that the Court would like to continue and see what negotiating points would have to be raised with them as to the present agreement.

The Court asks that the most aggressive implementation of this system be looked at in terms of time limits, and what budget implications are attendant to that. Defining "most aggressive," staff should show what it would look like to get it done the quickest way possible, how to finance the system, and how to implement it.

Maker and Second accept the Friendly Amendment by Judge Aleshire that staff at least meet the current service level.

Acceptance of the Friendly Amendment was made by Commissioner Moore and seconded by Commissioner Sonleitner.

Maker and Second accept the Friendly Amendment by Judge Aleshire that staff should assume that as soon as the Court gets to the budget discussion about how many ambulances to initially purchase, it should be assumed that the method by which Travis County will be paying for those will be in the Bond Issue coming up in the fall.

Acceptance of the Friendly Amendment was made by Commissioner Moore and seconded by Commissioner Sonleitner.

Maker accept the Friendly Amendment by Commissioner Sonleitner that staff should begin immediate discussions with the Travis County Purchasing Department regarding the development of any RFPs or Professional Services Agreements having to do with the procurement of a billing component or anything related to the procurement of any equipment and supplies that might be needed.

Acceptance of the Friendly Amendment was made by Commissioner Moore.

Maker accept the Friendly Amendment by Commissioner Sonleitner to give a heads up to the Human Resources Management Department (HRMD) regarding the potential need to recruit, hire, train, orient, or do anything that needs to be done relating to the hiring of any and all EMS personnel. The Market Match that should be used for equitable salaries (in Travis County) is the salary that the City of Austin is currently offering their EMS personnel.

A Clarification was made of the previous Friendly Amendment by Judge Aleshire that Travis County will be compensating at least at the level that the City of Austin is.

A Clarification was made of the previous Friendly Amendment by Commissioner Moore that HRMD needs to be alerted to develop the job descriptions, classifications, etc., that will be necessary to staff this system.

Acceptance of the Friendly Amendment was made by Commissioner Moore.

Maker accept the Friendly Amendment by Commissioner Sonleitner to give a heads up to the Travis County Sheriff's Office (TCSO) and any other law enforcement personnel regarding anything that may need to be brought forward related to the CAD and anything further that would need to be done relating to communications.

A Clarification was made of the previous Friendly Amendment by Commissioner Moore that the intent is for TCSO is to be looked at to be the dispatcher for this system.

Acceptance of the Friendly Amendment was made by Commissioner Moore.

Maker and Second accept the Friendly Amendment by Judge Aleshire that it be clear that these would be ALS units and that Travis County would continue to follow and enforce the Standard of Care document that has been used in Emergency Medical Services.
