The Motion was continued by Commissioner McKee and seconded by Commissioner Sonleitner that the issue of the Domestic Violence Court Investigator proceed to the FY 99 Budget Process, and that \$1,200.00 funding (\$100.00 per month) for the Underage Drinking Program be taken from the General Fund.

Clerk's Note: Judge Aleshire requested a division of the vote to include the issue of the COLLECTIONS DIVISION and the DOMESTIC VIOLENCE COURT separately from the UNDERAGE DRINKING PREVENTION PROGRAM.

A Clarification was made of the previous Motion by Commissioner Gómez that these votes are intended to advance these requests to the next step of the Budget Process, and that no promises are made by the Court as far as actual funding is concerned.
