Motion by Commissioner Gómez **and seconded by** Commissioner Davis that the Court fix the County's infrastructure, and that is our pay ranges, by shifting them 3%, that's 1% for each of the years; to me that means, I guess we'll have PBO to look at those figures, 3% which is 2.5 million; if you want to add that 2.5 million to 6% to allocate to the Departments to then tweak our infrastructure, that would be 8.5 million total.

A Restatement of the previous Motion was made by Judge Biscoe that the Motion is to indicate the Court's decision to allocate 8.5 million dollars to address compensation issues, and to direct that 3% of that be applied to move the scale forward.

A Restatement of the previous Motion was made by Commissioner Gómez, that by shifting that scale 3%, that will cover bringing everyone up to market, and then we have 5% for the Departments to do some tweaking, 3% to shift the pay ranges up, and then 5% for Departments, and that would be a total of 8% to devote to this project.

Motion by Judge Biscoe and seconded by Commissioner Davis to indicate our intention to allocate at a minimum 6%, that we indicate that we would like for Elected Officials to show us how they would use that money. For the Appointed Officials, who answer to the Commissioners' Court, to do the same thing by either a 2 ½% for performance pay or moving the pay range 2 ½ or 3%, so I guess I'm looking for some indication from them of how they would use the money, part of which would be performance, the other thing would be and/or moving the pay scale, but would be limited to 6%; that further we indicate our intention to do all we can during the Budget Process to augment this amount by 1% or 2% as the financial circumstances allow, and this Motion is more to give directions than anything else. Our request should include Elected Officials coming in at some later stage with their particular rendering, in about 3 weeks.

An Addition to the previous Motion was stated by Commissioner Sonleitner and agreed to by Judge Biscoe to include within the Motion the other things covered in 1-7, that we are going to correct job descriptions and job titles and move people in the appropriate ranges and address living wage issues which seem to be outside the 6%.

Judge Biscoe further stated to include that as well as a qualifier, which would be that this is not set in stone. I think there are specifics that we have to work out, probably sub-points under some of these, but that we're headed in this direction, and during this Budget Process we do plan to firm up these directives, and at the end of the Budget cycle have a written specific plan. The other thing is that our further intention, because I think it is important for Departments to know, is that we do plan to continue to do Market Salary Surveys as indicated here, what I don't say here is our intention to fund them as they're done.

Commissioner Gómez: and we say every 2 years, for a Market Salary Survey.

Judge Biscoe: two years is fine with me.

Commissioner Gómez: or every other year, I guess, is another way of saying it and commit to fund them.

Judge Biscoe: that's true, and we would ask HRMD to assist us by working with, I guess, the Departments, and try to figure out if we do it every other year: what Departments would be picked up in year one, what Departments in year two.

Commissioner Sonleitner: can we separate that stuff out? We're starting to get awfully mixed up here.

Judge Biscoe: that last part is a direction to try to help us and come back.

A Clarification of the previous Motion was made by Judge Biscoe to pull from the Motion references to the Market Salary Surveys next year and we'll just deal with that separately. That does leave 6%, does leave our intention for those Departments that work under the Commissioners' Court to do performance evaluations that meet expectations at about 2 ½%, or moving the scale, and it does include requests that Elected and Appointed Officials communicate with us in about 3 weeks and let us know generally how they would use this money. And if there are big issues that are still left, then it would help us to know what they are, and indicate our intention to try to increase the amount above 6%.

Commissioner Sonleitner: the point is what we're talking about is 6% to work on all of these issues, including performance pay, not in addition to performance pay.

Judge Biscoe: right now the 6% is the minimum in the Motion, and we'll try to increase that later.

A Clarification of the previous Motion was made by Judge Biscoe that, in this Motion, Judge Biscoe would e-mail those Officials and say, "It would help if you could let us know this 3 weeks from today", preferably 2 or 3 days before then so we can have a general discussion in Court.
