The second letter is to Williamson County, and it says basically, that we are glad to see the proposed Minute Order from the State of Texas; and we do notice that State Highway 45 Southeast is omitted; but we understand that based on previous negotiations and discussions with the State, it will get done; but we do think that in order to continue the fine spirit of cooperation between the two Counties, which will create the Regional Mobility Authority (RMA). there needs to be a Travis County project; and therefore, we believe that it is important for the Board to understand that its work is to complete projects in Williamson County and Travis County, and we ought to let them know that our understanding is that the second project done by the RMA will be Travis County.
