On Friday, the 9th day of January, 2004, the Commissioners' Court convened the Voting Session at 1:35 PM in the Commissioners' Courtroom, 1st Floor of the Ned Granger Administration Building, 314 West 11th Street, Austin, Texas. Clerk's Note: Judge Biscoe noted that Commissioner Precinct Two Karen Sonleitner and Commissioner Precinct Three Gerald Daugherty were not present in open Court when the Executive Session announcement was made, but they did join the other Commissioners in Executive Session before the discussion was begun, and were present for the entirety of the discussion.

Motion by Judge Biscoe **and seconded by** Commissioner Davis to authorize legal counsel representing Travis County in this matter to file a motion to stay the judgment, with the United States Supreme Court; and also, to authorize appeal of the adverse judgment to the United States Supreme Court; and to authorize the County Attorney's Office to continue to pay outside counsel from the amount authorized by the Commissioners' Court previously, and to call to our attention slightly in advance of the need for additional funds if any.
