Our goal is to hold them harmless, and if we need to put this back on the agenda for other standards, then that makes more sense too, if the original motion passes.

A Clarification of the Standing Motion was made by Judge Biscoe that "harmless" means having an opportunity to stay home if you want to-no adverse impact.

A Clarification of the Standing Motion was made by Judge Biscoe that the Motion is to invite competition by using a consultant to help us not only draft the document that we need to do that, but to help us analyze and evaluate, and at the same time, use a consultant to negotiate further with Nationwide; and my view early on was that it may well be, that the result of our negotiations with Nationwide could be Nationwide's proposal. I have no problem with them reserving a right to augment that towards the end. We have often sort of focused in on one vendor and directed Staff to go out and try to come back with the best proposal. I have something like that in mind, so in my view, it is a lot more open ended than I am hearing, but my goal is to make sure that county employees are in no worse position than they are now, certainly, and when I say, "hold harmless", I mean "avoid harmless impact".

A Clarification of the Standing Motion was made by Judge Biscoe that if we went out for an RFI (Request for Information), it would be for either exclusive or a coprovider with Nationwide, either/or; then bring the information to the Court, and let the Court decide which way to go, given any impact or any gain or loss to the employees.
