**THE COUNTY JUDGE OF TRAVIS COUNTY**

**County Judge Order 2022-01; Relating to COVID-19**

**Whereas**, on March 6, 2020, a Declaration of Local Disaster was issued by the Travis County Judge to allow the County of Travis ("County" or "Travis County"), Texas to take measures to reduce the possibility of exposure to COVID-19 and promote the health and safety of Travis County residents; and

**Whereas**, on March 13, 2020, a Declaration of State of Disaster was issued by Governor Greg Abbott to take additional steps to prepare for, respond to, and mitigate the spread of COVID-19 to protect the health and welfare of Texans; and

**Whereas**, the virus that causes COVID-19 is contagious and spreads through person-to-person contact, especially in group settings, is a virus that spreads mainly between people who are in close contact with one another respiratory droplets produced when an infected person speaks, sings, coughs, or sneezes; and

**Whereas**, infected persons can transmit the COVID-19 virus to others before showing any symptoms, and widespread and consistent use of face coverings over the nose and mouth when in public is a critical and necessary measure to help slow the spread of the virus while allowing local businesses to remain open and help the County economy recover; and

**Whereas**, a negative test result shows that an individual is not currently infected with COVID-19 and is a screening and infection control protocol that protects employees; and

**Whereas**, COVID-19 remains a public health threat due to the rise of variants of the disease and other factors; and

**Whereas**, COVID-19 and related variants continue to menace the health of Travis County residents and the area economy, the local Health Authority has advised that there is a need for education about health measures and continued vigilance in following health measures to prevent further transmission.

**Whereas**, the County Judge has determined that extraordinary emergency measures must be taken to try and mitigate the effects of this public health emergency and to facilitate a response to the public health threat;

**Whereas**, pursuant to Government Code section 418.108(g), a County Judge is authorized to control ingress and egress from a local disaster area, and control the movement of persons and the occupancy of premises in that disaster area; and


Whereas, Travis County includes all municipalities within the boundaries of Travis County listed in Exhibit A.

NOW THEREFORE, I, COUNTY JUDGE OF TRAVIS COUNTY, PURSUANT TO THE AUTHORITY VESTED BY TEXAS GOVERNMENT CODE CHAPTER 418, HEREBY FIND AND ORDER, EFFECTIVE AS OF 12:00 P.M. ON JANUARY 17, 2022, THAT IN THE COUNTY OF TRAVIS:


1. Protecting Customers and Employees and Preserving Adequate Workforce Capacity. To ensure that the County's health, health industry, and general economy can continue to recover, the County authorizes a person in control of a Site to exercise discretion and impose one or more of the following requirements:
  - (a) require employees and customers to wear face coverings while on the Site;
  - (b) require employees and customers to show a negative COVID-19 test result to enter the Site;
  - (c) require employees to provide proof that the employee is vaccinated and, when appropriate, boosted; or
  - (d) allow employees or customers choose to provide proof that the employee or customer is vaccinated in lieu of showing a negative COVID-19 test result.
2. Notice of Protections Provided. A person in control of a Site must post a notice that identifies whether the person in control of the Site requires face coverings, negative COVID-19 tests, or vaccinations. The notice must be posted at each entry to the Site. A notice template is attached as Exhibit B.
3. General Signage Required. A person in control of a Site must post the sign attached as Exhibit C. The sign must be posted in a conspicuous location that is sufficient to provide notice to employees and customers of all health and safety recommendations during Stages 3, 4 and 5 as set forth in Austin Public Health's Risk-Based Chart attached as Exhibit D.
4. Definition of Site. A "Site" means property where goods and services are provided directly to the public. In Sections 2 and 3, a Site does not include:
  - property maintained by a governmental entity; or
  - dwelling unit where an individual resides.
5. ENFORCEMENT. A violation of this Order may be punishable through civil or criminal enforcement. The Travis County Sheriff's Office, the Travis County Fire Marshal's Office, and other peace officers are hereby authorized to enforce this Order. A criminal violation of this Order is a misdemeanor punishable by a fine not to exceed \$1,000, but not by confinement. A criminal violation of this Order may be enforced by the filing of a probable cause affidavit alleging the violation with the appropriate court or by issuing a citation to the person violating the Order, which contains written notice of the name and address of the person charged, and the offense charged

6. The Austin Public Health Department and the Travis County Clerk will post this Order on their websites.
7. **Savings Clause.** If any provision of this Order or its application to any person or circumstance is held to be invalid, then the remainder of the Order, including the application of such part or provision to other persons or circumstances, shall not be affected and shall continue in full force and effect. To this end, the provisions of this Order are severable.
8. This Order is issued in accordance with and incorporates by reference all declarations, findings, and recitations set out in the preamble to this Order. This Order supplements any prior order issued by the Travis County Judge. Nothing in this Order prohibits or requires a person in control of a Site to:
  - (a) require or enforce the wearing of face coverings;
  - (b) require employees to obtain vaccines and boosters or to provide proof that the employee is vaccinated and boosted;
  - (c) require employees or customers to obtain testing; or
  - (d) accept proof of vaccination in lieu of testing.





