

NOTICE OF DIRECTOR ELECTION

Notice is hereby given that North Austin Municipal Utility District No. 1 (the “*District*”) will hold an election on November 3, 2020 between the hours of 7:00 a.m. and 7:00 p.m., at the polling place for each election precinct established by Travis County and Williamson County, Texas, for the purpose of electing a director to serve in Place 1, a director to service in Place 3, and a director to serve in Place 5, each of whom will serve a four-year term.

The ballots used in the election will have printed on them the names of all candidates for each of the three places for the office of director to have their names printed on the ballot at least 78 days before the election, and one blank space for write-in votes for any candidate for each of the three places for the office of director who has filed a declaration of write-in candidacy at least 74 days before the election.

The presiding judges, alternate presiding judges, and clerks for the election selected and appointed by Travis County and Williamson County in compliance with the requirements of State law are designated and appointed as election officers for the holding of the election. The presiding judges, alternate presiding judges, and clerks will perform the functions and duties of their respective positions that are provided by State law.

The District is divided into a total of five election precincts, one of which is in Travis County and four of which are in Williamson County. The respective Election Day polling places will be the polling places designated by Travis County for the election, as set forth on **Exhibit “1”**, and the polling places designated by Williamson County for the election, as set forth on **Exhibit “2”**.

The regular early voting clerk for Travis County is Dana DeBeauvoir, Travis County Elections Administrator. The regular early voting clerk for Williamson County is Christopher J. Davis, Williamson County Elections Administrator. Early voting by personal appearance will be conducted at the times, dates, and polling places established for early voting by Travis County and Williamson County, as set forth on **Exhibits “3”** and **“4”**, respectively.
