**ORDER DECLARING ELECTION OF UNOPPOSED CANDIDATES
AND CANCELING NOVEMBER 3, 2020 DIRECTOR ELECTION**

Recitals

The Board of Directors ("Board") of Southeast Travis County Municipal Utility District No. 1 has called a director election for November 3, 2020 (the "Election").

The deadline to submit an application for a place on the ballot for the Election was August 17, 2020. The deadline to file an application for write-in candidacy for the Election was August 21, 2020.

The Secretary of the Board is the authority responsible for having the official ballots prepared for the Election and, on September 2, 2020, submitted to the Board a "Certification of Unopposed Status of Candidates for the November 3, 2020 Director Election", attached as **Exhibit "A"**.

Under Section 2.053 of the Texas Election Code, if the Board receives a certification of unopposed status of candidates, it may declare each unopposed candidate elected to office.

Therefore, the Board of Southeast Travis County Municipal Utility District No. 1 orders that:

1. The "Certification of Unopposed Status of Candidates for the November 3, 2020 Director Election", submitted on September 2, 2020, is accepted.
2. Jed Crump, Robert C. Thompson, and Hank B. Smith are elected to office as Directors for Southeast Travis County Municipal Utility District No. 1, their terms will begin on November 3, 2020, and they will begin their duties as Directors after executing a Statement of Elected Officer and taking the Oath of Office.
3. The Election is canceled.
4. This Order will constitute a certificate of election, and the Secretary of the Board is directed to issue and deliver a copy to each candidate as required by Section 67.016 of the Texas Election Code and to post a copy of this Order at the polling place on the Election day.
5. This Order may be executed in multiple counterparts, each of which will be deemed an original and all of which together will constitute one and the same instrument. An electronic signature, a facsimile or other electronic copy of an original signature, and a counterpart transmitted electronically (e.g., by fax, email, text, or similar means), will be deemed to be, and will have the same force and effect as, an original signature for all purposes.

5. Esta Orden puede ser ejecutada en ejemplares múltiples, cada uno de los cuales en su conjunto serán considerados como originales y todos juntos constituirán un solo y único instrumento. Una firma electrónica, un facsímil u otra copia electrónica de una firma original, y un ejemplar transmitido electrónicamente (por ejemplo, por facsímil, por correo electrónico, por mensaje de texto, u otros medios similares) constituirán, y tendrán la misma fuerza y efecto como si dicha firma fuera un original de la misma a todos efectos prácticos.

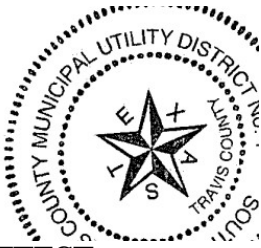

**CERTIFICATION OF UNOPPOSED STATUS OF CANDIDATES
FOR THE NOVEMBER 3, 2020 DIRECTOR ELECTION**

The undersigned, the Secretary of the Board of Directors of Southeast Travis County Municipal Utility District No. 1 ("*District*"), is the authority responsible for having the official ballots prepared for the November 3, 2020 Director election for the District and certifies that:
