

AN ORDER TO SET THE TERMS FOR THE TRAVIS COUNTY STATUTORY COUNTY COURTS. STATUTORY PROBATE COURTS. AND JUSTICE OF THE PEACE COURTS

RECITALS

The designation of the terms of statutory county courts is required by Government Code Section 25.0016.

The designation of the terms of statutory probate courts is required by Government Code Section 25.0035.

The designation of the terms of justice courts is required by Government Code Section 27.051.

ORDER

The Commissioners Court of Travis County. Texas hereby orders that the two terms set for:

the Travis County Statutory County Courts;

the Travis County Probate Courts; and

the Travis County Justice of the Peace Courts

for Calendar Year 2026 shall be January 1 - June 30, and July 1 - December 31.

Except as indicated below during a disaster, this Court further orders that the place for holding the Travis County Justice of the Peace Courts shall be at the following locations, or virtually as authorized by the Texas Supreme Court, as follows:

Precinct 1, 4717 Heflin Lane, Austin, TX 78721;

Precinct 2, 10409 Burnet Rd., Austin. Texas 78758:

Precinct 3, 8656-B West Hwy 71 Austin, Texas 78735;

Precinct 4, 4011 McKinney Falls Parkway, Austin, Texas 78744;

Precinct 5, 1000 Guadalupe Street, Austin, TX 78701, and

the time for meeting shall be at least during the hours between 8:00 A.M. - 4:30 P.M., Monday - Friday, as cases may arise, and those other times that the Justices may desire.

Notwithstanding the above and in accordance with sections 25.0016(b), 25.0035(b) and 27.0515 Government Code, if a disaster, as defined by Section 418.004 Government Code, precludes a Statutory County Court or Probate Court from holding its terms or precludes a justice court from holding its terms or in locations of the affected statutory county in accordance with the times prescribed by the commissioners court, the statutory county court, probate court or the justice of affected justice of the peace court, may designate the terms, sessions and location of

court unless otherwise indicated by the presiding judge of the administrative judicial region or order of the Texas Supreme Court.
